Prof. Yueh-Hsun Tsai is currently the Dean and Associate Professor of Law of the Graduate School of Sci. & Tech. Law, NYUST, Taiwan. He obtained his J.D. degree from Tulane University School of Law, and LL.M. degree from Northwestern University Law School. He focuses his research on the fields of Intellectual Property Law, Technology Law, New Energy Law, and Antitrust and I.P., and has also published several books, law review articles and conference papers related to these fields.

In addition to his academic works, Prof. Tsai also serves as the P.I., co P.I., consultant or committee member of several major research and training projects/programs for the National Science Council, Ministry of Economic Affairs, Ministry of Education and Taiwan I.P. Court, etc.

Prior to his academia appointments, Prof. Tsai practiced law with Lee & Li Attorneys-at-law, the largest law firm in Taiwan, where he participated in several deal of the year projects in the financial markets. Prof. Tsai is also the member of the California State Bar Association, New York State Bar Association and the Chinese Arbitration Association, Taipei.
